1. ACCEPTANCE AND VALIDITY:

For this certificate to be valid, the seller/lessor shall exercise good faith in accepting this certificate, which includes: (1) the certificate shall be completed properly; (2) the certificate shall be in the seller/lessor's possession within 60 days from the date of sale/lease; (3) the certificate does not contain information which is knowingly false; and (4) the property or service is consistent with the exemption to which the customer is entitled. For more information, refer to Exemption Certificates, Title 61 PA Code §32.2. An invalid certificate may subject the seller/lessor to the tax.

2. REPRODUCTION OF FORM:

This form may be reproduced but shall contain the same information as appears on this form.


3. RETENTION:

The seller or lessor must retain this certificate for at least four years from the date of the exempt sale to which the certificate applies.

DO NOT RETURN THIS FORM TO THE PA DEPARTMENT OF REVENUE.

4. EXEMPT ORGANIZATIONS:

This form may be used in conjunction with form REV-1715, Exempt Organization Declaration of Sales Tax Exemption, when a purchase of \$200 or more is made by an organization which is registered with the PA Department of Revenue as an exempt organization. These organizations are assigned an exemption number, beginning with the two digits 75 (example: 75-00000-0).

Dear Vendor:

The City of Harrisburg is an incorporated municipal entity utilizing a Mayor/Council form of government. Operating in this capacity, the City is an exempt payee relative to both Federal income tax and state sales tax; Federal tax exemptions apply here with the City's classification as an exempt organization (local governmental unit) under Internal Revenue Code section 509(a)(1). Further, specific to Pennsylvania sales tax, the City is also exempt due to being classified as a political subdivision of the Commonwealth of Pennsylvania. For entities of this classification, e.g., cities, townships, boroughs, the Pennsylvania Department of Revenue does not issue specific exemption numbers as it does for other exempt organizations.

If necessary, further confirmation of this stated exempt status can be obtained from the Commonwealth by contacting the Pennsylvania Department of Revenue, Miscellaneous Tax Division at 717-783-5473.
